

NOTHERN CALIFORNIA BORDER COLLIE RESCUE & ADOPTIONS
DOG OWNER WEB PAGE AND FACEBOOK LISTING RELEASE AND WAIVER

At the request of the dog Owner named below and without fee or compensation being required, Northern California Border Collie Rescue & Adoptions Inc. (NCBCRA) will list the Owner's dog on NCBCRA's "Dogs Available Directly from Owners" and Facebook web pages for the purpose of providing public exposure towards the Owner's desire to find an alternate home for the dog. At Owner's discretion, a donation may be provided to NCBCRA for such listing, but payment or other compensation is not required for such listing or if re-homing of Owner's dog should occur. Owner hereby attests to be the legal owner of the dog and shall provide NCBCRA with photographs and a written description for the listing that accurately describes Owner's dog. Such listing is limited to web page exposure and NCBCRA shall not promote Owner's dog in any other manner. NCBCRA shall not review or evaluate Owner's dog or any party interested in obtaining Owner's dog. All communications with an interested party will be solely by the Owner and without required knowledge or consent of NCBCRA. Any resultant transaction between an interested party and Owner shall be a private matter and not reviewed or sanctioned by NCBCRA. Any re-homing of Owner's dog shall not be considered an adoption by or on behalf of NCBCRA. NCBCRA shall unilaterally remove such listing after 90 days unless requested by Owner to extend the listing time. NCBCRA reserves the right at its sole discretion to remove such listing at any time. In consideration of providing Owner such a listing, Owner agrees to indemnify, defend, and hold harmless NCBCRA's owners, directors, officers, employees, volunteers, representatives and agents, and defend any action brought against same with respect to any claim, demand, cause of action, debt or liability, including reasonable attorneys' fees, to the extent that such action is based upon a claim that: (i) if true, would constitute a breach of any of Owner's representations, warranties, or agreements hereunder; (ii) arises out of the negligence or willful misconduct of Owner; or (iii) arises directly or indirectly out of or in connection with such listing and from liability for injuries suffered by any person relating to the Owner, excluding, however, claims or demands arising out of the intentional misconduct or sole negligence of NCBCRA.
